In agriculture, Passron INTERNATIONAL - FZCO is a comprehensive input provider, offering a full range of fertilizers—including Urea, NPK , h i gh-quality seeds/seedlings for cereals and vegetables, and a complete line of agrochemicals such as herbicides, insecticides, fungicides, and fumigants.

We are proud to collaborate with Dangote Fertilizer Limited, the world's largest granulated urea fertilizer complex, representing a \$2.5 billion investment with an annual capacity of three million tonnes.

Additionally, we are partners with **Dangote Refinery Limited**, which operates a 650,000 barrels per day (bpd) integrated refinery and other petrochemical in the Lekki Free Zone near Lagos, Nigeria. This facility is the Africa's biggest oil refinery and the world's largest single-train facility.
